Bonavista Energy Corporation Announces Increase to Exchangeable Share Ratio

Calgary – Bonavista Energy Corporation (“Bonavista”) is pleased to announce the increase to the Exchange Ratio of its exchangeable shares from 1.03943 to 1.04424. This increase will be effective on November 15, 2011 (the “Effective Date”).
