### Bonavista Energy Trust Announces Increase to Exchangeable Share Ratio

Calgary – Bonavista Energy Trust is pleased to announce the increase to the Exchange Ratio of the Exchangeable Shares of Bonavista Petroleum Ltd. from 2.32051 to 2.33604. This increase will be effective on August 16, 2010.
